Fall is a wonderful time in the American Studies community: the students return from summer trips, volunteering, research, and work excited for the year ahead. The seniors are beginning to work intensely on their research projects, our 14 new majors are starting the 301 seminar series, and the juniors are roving about campus, enrolling in classes with the freedom and intent that this unique major affords. I'm so delighted to take the helm from Geraldo Cadava as Director this year—I was affiliated with American Studies many years ago as a Postdoctoral Fellow, and because my own doctoral training is in American Studies, I've always had a soft spot for this program.

But methodology aside, I am struck anew by how special American Studies students are Northwestern: at a time of concern about classrooms turned into AI modules, these students seek rigor, friction, and challenge. As some worry about students avoiding ideas different than their own, these students seek them out and engage in difficult conversation. They look for learning that is deep and broad, fun and engaged, transformative and meaningful.

This year's crew includes interests ranging from journalism to environmental policy and from global health to dance. Their extracurriculars span Greek life, mock trial, rugby, and debate. This quarter alone, they are studying at Oxford and in Washington, D.C., not to mention Copenhagen, the United Kingdom, and Spain. Our 25 current majors include five Phi Beta Kappa scholars (a stunning percentage). Last year's graduates include a Fulbright Scholar; matriculates and researchers at Cambridge, Johns Hopkins, and the London School of Economics; and young talent at Spencer Stuart, Creative Artists Agency, and Evercore Investment Bank. These varied interests and outcomes testify to the power of an interdisciplinary education: our majors are thinkers prepared for a complex world.

It was wonderful to see many of you at the celebration of the 50th Anniversary of Northwestern American Studies last year. Many of you humored me as I spoke about my obsession with megalodon conspiracy theory and fear of sharks, and we raised our glasses to many past directors and staff members in attendance. Of course we saw Carl Smith, Kate Baldwin, Ivy Wilson, Shana Bernstein, Jay Grossman, Henry Binford, Julie Lavin, Natasha Dennison, Calos Ballinas, Kevin Boyle, Nicolette Bruner, Jerry Goldman, Doug Kiel, Liz Pardoe, Adrian Randolph, Liz Son, Rebecca Zorach, Julia Stern, Robert Lerner, and Joe Germuska. It was nice to see the familiar faces of alumni and to hear what they've been up to after graduation. I hope more of you will get in touch with us to let us know what you've been doing!

Next Fourth of July, America will celebrate the 250th anniversary of its founding, and we will embark together on an exploration of what it means to pursue American Studies at this watershed moment. When I think of the work ahead, I am heartened to undertake it with these students.

Kathleen Belew (Associate Professor, History) is a lifelong pursuer of interdisciplinary scholarship, delighted to direct the American Studies Program at Northwestern. She earned a doctorate in American Studies from Yale University and an undergrad degree in Comparative History of Ideas from the University of Washington. This education fed her interest in story-driven research and her specialization in the history of the present.

Belew's forthcoming book, *Home at the End of the World*, illuminates an era of apocalypse through a history focused on her native Colorado where, in the 1990s, high-profile kidnappings and murders, right-wing religious ideology, and a mass shooting exposed rents in America's social fabric, and dramatically changed our relationship with place, violence, and politics (Random House).

Her first book, *Bring the War Home: The White Power Movement and Paramilitary America* explores how white power activists created a social movement through a common story about betrayal by the government, war, and its weapons, uniforms, and technologies. By uniting Ku Klux Klan, neo-Nazi, skinhead, and other groups, the movement mobilized and carried out escalating acts of violence that reached a crescendo in the 1995 bombing of Oklahoma City. This movement was never adequately confronted, and remains a threat to American democracy.

She is co-editor of and contributor to *A Field Guide to White Supremacy*, and has contributed essays to *Myth America*, *The Presidency of Donald J. Trump: A First Historical Assessment*, and *Conspiracy/Theory*. Her award-winning teaching centers on the broad themes of history of the present, conservatism, race, gender, violence, identity, and the meaning of war.

Belew has spoken about her scholarly research on wide variety of platforms, including The Rachel Maddow Show, The Last Word With Lawrence O'Donnell, AC 360 with Anderson Cooper, Frontline, Fresh Air, and All Things Considered. Her work has featured prominently in documentaries such as Homegrown Hate: The War Among Us (ABC) and Documenting Hate: New American Nazis (Frontline). Her research has received the support of the Chauncey and Marion Deering McCormick Foundation, the Andrew W. Mellon Foundation, and the Jacob K. Javits Foundation. Belew earned her BA in the Comparative History of Ideas from the University of Washington, where she was named Dean's Medalist in the Humanities. Belew has held postdoctoral fellowships from the Center for Advanced Study in the Behavioral Sciences at Stanford University (2019-20), Northwestern University, and Rutgers University.

Michael J. Allen (Ph.D., Northwestern University, 2003) researches the relationship between ideas and action in US politics. His book Until The Last Man Comes Home: POWs, MIAs, and the Unending Vietnam War (University of North Carolina Press, 2009) examined the political and cultural legacies of American defeat in the Vietnam Wars through a history of the POW/MIA movement. His current book-in-progress The Center Ring: The Making and Breaking of the Liberal Presidency examines the relationship between liberal reform and presidential power from Franklin Roosevelt to Richard Nixon.



Shana Bernstein (Ph.D., Stanford, 2003) is an historian of the twentieth-century United States, with a particular interest in social reform movements, including civil rights and environmental health and justice. Originally from Northern California, where she completed degrees at UC Berkeley and Stanford, she initially joined Northwestern as a Mellon Postdoctoral Fellow in Latino Studies before accepting a tenure-track position in History at Southwestern University in 2004. She rejoined the Northwestern faculty in 2014 as a Clinical Associate Professor of Legal Studies.

Her first book, *Bridges of Reform: Interracial Civil Rights Activism in Twentieth-Century Los Angeles* (Oxford, 2011), reinterprets U.S. civil rights activism by revealing its roots in the interracial efforts of Mexican, Jewish, African, and Japanese Americans in mid-century Los Angeles. It also argues that the early Cold War facilitated, rather than derailed, some forms of activism. Bernstein has also written academic articles on the history of environmental health and civil rights, and has written essays for CNN, *The Forward, Talking Points Memo, The Hill, Pacific Standard, American Prospect*, and the *Austin American Statesman*. She has received fellowships including from the Huntington Library and the Mellon Foundation, and is a distinguished lecturer for the Organization of American Historians.

Bernstein is currently working on a project that uses the history of strawberries as a lens for exploring the intersection of worker health, consumer health, and environmental health. She teaches undergraduate courses on comparative race and ethnicity, immigration, and health and inequality.

Nicolette Bruner (Ph.D. in English Language and Literature, University of Michigan; J.D., University of Michigan Law School) is Assistant Professor of Instruction at the Center for Legal Studies and the Program in American Studies. Prior to joining Northwestern's faculty, she was a postdoctoral fellow with the Stevanovich Institute on the Formation of Knowledge at the University of Chicago and taught in the Department of English at Western Kentucky University.

Bruner's research explores how the law shapes the way humans understand and interact with the nonhuman entities and systems around them. Her current book project, Thing People: Living with Corporations and Other Nonhumans, examines how the legal doctrine of corporate personhood offers a framework for articulating the rights and responsibilities of other nonhuman entities, including animals, plants, rivers, and robots. She also teaches and works in American literature, corporate law and policy, jurisprudence, and the environmental humanities.



Geraldo L. Cadava is an historian of the United States. He focuses on the history of Latinos in the United States and the U.S.-Mexico borderlands. Originally from Tucson, Arizona, he came to Northwestern after finishing his Ph.D. at Yale University.

He is the author of *The Hispanic Republican: The Shaping of an American Political Identity, from Nixon to Trump* (New York: Ecco, 2020); and also *Standing on Common Ground: The Making of a Sunbelt Borderland* (Harvard University Press, 2013), about the Arizona-Sonora borderland since World War II. He is now working on a book about Latino history over the past 500 years, tentatively titled *A Thousand Bridges*, to be published by Crown in 2026.

Cadava is also a Contributing Writer at *The New Yorker*; co-Editor-in-Chief of the online magazine *Public Books*; host of the podcast *Writing Latinos*; and Principal Investigator for Northwestern's Mellon Mays Undergraduate Fellowship Program.


At Northwestern, he teaches courses on Latino History, the American West, the U.S.-Mexico borderlands, migration to and from Latin America, and other topics in U.S. history, including Watergate, the 2016 election, and the musical *Hamilton*.

Robert Orsi (Ph.D. Philosophy, Yale University) is the first holder of the Grace Craddock Nagle Chair in Catholic Studies. Professor Orsi studies American religious history and contemporary practice; American Catholicism in both historical and ethnographic perspective; and he is widely recognized also for his work on theory and method for the study of religion. In 2002-2003, he was president of the American Academy of Religion. Professor Orsi has held fellowships from the Guggenheim Foundation, the National Endowment for the Humanities, and the Fulbright Foundation. He is a member of the American Academy of Arts and Sciences. In 2010 he received the E. Leroy Hall Award for Teaching Excellence, Weinberg College of Arts and Sciences, Northwestern University, the highest recognition for teaching offered by WCAS.



lvy Wilson (Ph.D., Yale University) teaches courses on the comparative literatures of the black diaspora and U.S. literary studies with a particular emphasis on African American culture. His book, *Specters of Democracy: Blackness and the Aesthetics of Nationalism* (Oxford University Press, 2011), interrogates how the figurations and tropes of blackness were used to produce the social equations that regulated the cultural meanings of U.S. citizenship and traces how African American intellectuals manipulated the field of aesthetics as a means to enter into political discourse about the forms of subjectivity and national belonging. Along with recent articles in *ESQ*, *Arizona Quarterly*, and *PMLA*, his other work in U.S. literary studies includes two forthcoming edited books on the nineteenth-century poets James Monroe Whitfield and Albery Allson Whitman. His current research interests focus on the solubility of nationalism in relationship to theories of the diaspora, global economies of culture, and circuits of the super-national and sub-national.



Other Noteworthy Awards, Grants and Fellowships

Jane Clarke

We proudly celebrate Jane Clarke, Class of 2024, on being chosen as a Gates Cambridge Scholar for 2025. Jane studied history and American Studies at Northwestern. She is pursuing a master of philosophy in American History at Cambridge, where she will build on her undergraduate thesis project, which examined ideologies of imperialism in American children's literature in the first half of the 20th century. She plans to explore what is distinctive about how American imperialism is depicted by adding a comparison with British children's literature from the same period. While global history and the study of empire tend to focus on the big-picture or diplomatic level, Clarke's project focuses on these topics through the lens of pop culture and ordinary people.

Ultimately, Jane's goal is to become a historian in a publicfacing setting, which is why she was drawn to the Gates Cambridge program.



Simon Carr spent summer 2025 researching Illinois's Prisoner Review Board for PNAP (Prison + Neighborhood Arts/Education Project), a nonprofit in Chicago. His work will be turned into a zine and used for PNAP's participatory defense project, which helps folks navigate Illinois' clemency process. Simon was awarded a grant from Northwestern's Summer Internship Grant Program (SIGP).

Sharmel Gibson will continue to work with Emerging Scholars working on developing their own independent research project to research the education system (past and present) in Detroit with a focus on for profit charter schools.
